$\int \sqrt{1+x^2} \, dx$ . Answer: Using The Substitution  $U = 1+x^2$  We Get  $\int \sqrt{1+x^2} \, dx = \int \sqrt{U} \, \frac{1}{2} U^{-1/2} dU = \int \frac{1}{2} U^{1/2} dU = \frac{1}{2} \cdot \frac{2}{3} U^{3/2} + C = \frac{1}{3} (1+x^2)^{3/2} + C$ .
